Do you have a Business Continuity Plan in place?	Yes - Our Business Continuity Management System (BCMS) is certified to the ISO 22301:2019 standard. Our Business Continuity Plan focuses on prioritised key processes and systems which have been identified through risk assessment and business impact analysis activities across the business and are tested regularly to enable continuous improvement and refinement. The planning is based on worse case scenarios such as prolonged lack of access to our headquarters as well as data centre disaster scenarios affecting our primary customer services.
When was the last time you tested the Business Continuity Plan?	We continually test throughout the year (including data centre failover capability and our ability to run all business functions from a remote location).
Do you have Recovery Time Objectives (RTO) and Recovery Point Objectives (RPO) for Business Continuity?	Yes - for the NetPro infrastructure and SIMPro application we aim for a recovery time to be within our standard Service Levels for a major P1 interruption, as we have failover capabilities in place which enable this. Our recovery point objective is met by our data replication arrangements across primary and secondary data centres.
